GENERAL ASSEMBLY OF BIBLE STUDENTS
Pastor Russell's Address at Glen Echo Park, Washington, D. C.

He Declares the Bible to Be the Only Center of Attraction and Standard of Faith—Four Thousand Representatives Present From All Parts.



Washington, D. C., July 14.—The International Bible Students Association closed a very successful eight-days' Convention at Glen Echo Park tonight. Approximately forty speakers have addressed the Convention. Pastor Russell was the principal speaker this afternoon. His text was, "But ye are come . . . to the General Assembly and Church of the First-born, which are written in Heaven."—Hebrews xii, 23.

The speaker declared that St. Paul points us back to the institution of the Jewish Law Covenant at Mt. Sinai and uses it as a picture or type of experiences of the Church to be expected at the Second Coming of Christ and the establishment of His glorious Kingdom. St. Paul pictures the march of the Israelites from the Red Sea to Mt. Sinai, implying that some got to the mountain much in advance of the others, but waited there for the General Assembly. The Apostle points us back to the awful experiences connected with the inauguration of the Law Covenant—Mt. Sinai smoking, lightning flashing from the cloud and thick darkness which enveloped the mountain, the earth trembling, the Voice of God heard, the people in fear. All these things, said the Pastor, according to St. Paul, were foreshadowings of still more wonderful things to be expected in the near future in connection with the inauguration of the New Covenant. Many had misapprehended the Apostle's teaching in respect to the New Covenant and thought it already sealed and in operation. But not so. The Scriptures assure us that the work of Christ and the Church during this Age has been a preparatory one, without which the New Covenant could not go into effect.

A Time of Terrible Trouble.
Everywhere the Bible associates with the coming of Christ a great trouble upon the world and assures us that the faithful of the Church will be spared from it by their resurrection change. The plowshare of trouble will upset human pride and humble the world and make them glad to welcome the Messianic Kingdom then to be established for the purpose of bringing to Israel and to the world the long promised blessings of the New Covenant. The introduction of this Kingdom St. Peter styles the Day-dawn. (II Peter i, 19.) He describes its work as most blessed, saying, "Times of refreshing shall come from the presence of the Lord—He shall send forth Jesus Christ—whom the heavens must retain until the Times of Restoration of all things, which God hath spoken by the mouth of all His holy Prophets since the world began."—Acts iii, 19-21.

St. Paul's interpretation of the Mt. Sinai experiences would imply a "Day of Vengeance"—the very term which the Bible uses. Society will be so shaken and its experiences will be so dreadful that, like the Israelites of old, all will be ready to entreat for the Great Mediator—The Christ, Head and Body—Jesus and His Church in glory—to stand between them and the Almighty. It will be in response to this universal cry that the Messianic Kingdom will be established and by the New Covenant take over the control of the entire world of mankind, for whom by the grace of God, Jesus Christ tasted death.—Hebrews ii, 9.
Terrible as the squaring of the world's accounts will be preparatory to the opening of the New Dispensation with a clean page, they are rational as well as Scriptural. Humanity will be able to look up to God and acknowledge His Wisdom and Justice, and then to thank Him for the loving provision of the Messianic Kingdom, under whose beneficent reign they may be helped back to full human perfection and to a world-wide Eden.

The Church in General Assembly.
We have greatly enjoyed, dear brethren, our Convention or Assembly. But what will it be to be there—in the General Assembly of the entire elect Church of God? There will be no sectarianism there, though these doubtless will be saints of God from every sect in that Convention in Glory! Let us carry with us a sense of the realities of the glorious promises of the Bible, which, we believe, are hastening to fulfillment.
Even now, on every hand, we see the evidences of social unrest; and the wonderful blessings of our day are being received by unthankful hearts with ingratitude, breeding discontent and presaging the awful anarchy which the Bible teaches us to expect. It is a time for faithfulness to God, to His Word, on the part of all who are of "the household of faith," of every nation and denomination. It is a time for the Bride to make herself ready for the Bridegroom.

Ten Years of Advancement of the Union Pacific Railroad
TEN YEARS AGO LAST MONTH
As clipped from the newspapers of that date.
Announcement was made at the Union Pacific headquarters that the double tracking of the line from Omaha to Valley was to be completed in the near future.

A comparison of double tracking figures between the years 1902 and 1912 shows a vast and interesting growth. Prior to 1902 the Union Pacific had a total of only 74.41 miles of double track. Today there is an unbroken stretch of double track of 364 miles from Omaha to Julesburg, Colo., while there is a total of 727 miles of double track on the main line and branches—not including 130 miles now being laid.
While reviewing the above figures, note a few of the improvements and extensions other than double-tracking that have been brought about during the last decade.
The equipment of the entire line with a system of automatic electric block safety signals affording protection to patrons and employes.
The ballasting of its roadbed with Sherman gravel (disintegrated granite) insuring the traveler freedom from all road dust.
The straightening of sharp curves, the elimination of steep grades, the shortening of distance by cut-offs, the tunneling of solid granite mountains, the filling in of deep valleys, the bridging of wide expanses of water and the making of various other improvements that contribute to the comfort and safety of its patrons.

MARKET REPORT

Kansas City Stock Yards, Sept. 3, 1912.—Though the cattle market still bore the brand of "steady to weak" it has been wearing for three or four weeks yesterday, there was a shade better feeling evident. Quarantine cattle sold steady. The run today, is 17,000 head, four thousand more than the estimate for today, and the market is steady to a shade lower. The best Steers here yesterday brought \$10.50, and the top today is \$10.35, indicating that prices have softened a little since a week ago throughout the entire cattle structure. Pasture men shipped lightly Sunday, but they loaded a good many cattle yesterday. These cattle are 25 to 50 cents lower than a week ago, at \$6.65 to \$8.75. Quarantine cattle carried more quality yesterday than heretofore, tops reaching \$6.50. The run from the South today is 100, cars, market is about steady, steers at \$4.10 to \$6.06, including some light ones from Arkansas at the lower figure. Travelers from Oklahoma arrived here today say that country is suffering for rain, and unless it gets it this week we may look for heavy supplies of Southern next Monday. Kansas got a good rain last night and yesterday. Controversy as to corn probabilities has about ceased, all agreeing that a bumper crop is assured. Demand for country kinds is at a maximum, 20,000 head going to the country last week from here. Feeders are half a dollar lower than last week at \$6.25 to \$7.25 for most sales. Stockers have held up almost steady, sales largely at \$4.70 to \$6.35. Hogs came in more liberally today, though the total was only 7100 head for the day. The market is steady to 5 lower on light hogs, with a top of \$8.82 1-2, but butchers and heavies are off 10 cents today, bulk of sales at \$8.45 to \$8.70. The spread in prices is widening, which puts country buyers against a hard proposition, to get hogs worth the money at country shipping points. Sheep and lambs are strong today, run 11,000 head. Lambs brought \$7.90 today, out of the same lot that sold at \$6.85 yesterday. Feeding lambs are worth \$6.40 for best, feeding yearlings \$5.25, and feeding wethers \$4.10 for best, prices within close range of the prices the packers are paying for fat stock.

HOUSE CONCURRENT RESOLUTION No. 3
Granting equal rights and privileges to women.
He it resolved by the Legislature of the State of Kansas, two-thirds of the members elected to each House thereon concurring therein:
That the following proposition to amend the constitution of the state of Kansas be hereby submitted to the qualified electors of the state for their approval or rejection, to-wit:
SECTION 1. The rights of citizens of the state of Kansas to vote and hold office shall not be denied or abridged on account of sex.
SEC. 2. This proposition shall be submitted to the electors of this state at the election for representatives to the Legislature in the year 1912. The amendment hereby proposed shall be known on the official ballot by the following title: Amendment to the constitution granting equal rights and privileges to women, and the vote for or against such amendment shall be taken as provided by law.
SEC. 3. This amendment, if adopted, shall be known as section 8 of article 5 of the constitution of the state of Kansas.
SEC. 4. This resolution shall take effect and be force from and after its publication in the statute book.
