If there is one thing more certain than any other, it is that President Taft is not dominated by the so-called political bosses. The truth is that he refused to be dominated by the greatest of modern bosses, Theodore Roosevelt. If President Taft had granted all the favors which Roosevelt asked, if he had appointed to office all the persons whom Mr. Roosevelt recommended, and if he had been, in short, Mr. Roosevelt's plant tool he would not today find himself opposed for the presidency by his predecessor. Mr. Taft has never been dominated by the so-called bosses. He has made appointments to office for the good of the public service and not to oblige men who desired recognition for political reasons. It is a common saying, accepted by all men, that Mr. Taft is not a politician. The very frequency of this assertion proves that President Taft has a free and courageous mind which acts independently of suggestions from those who are in politics for purely selfish reasons. The situation in which Mr. Taft finds himself today, when he is opposed for the presidency by a man whose domination he would not accept, and when the "bosses" are giving him only lukewarm support, is a competent answer to the untruthful charge that he is subject to "boss" domination.—Ex.

### MARKET REPORT

Kansas City Stock Yards, October 1, 1912. The same words are used in describing the market today that have been in use since the first of last week, steady to weak. Prime steers and butcher grades are steady, medium steers and feeders are weak, stock steers steady. Runs are exceeding first estimate this week, the supply today counting up 22,000 head including 2000 calves. Recent frosts are hurrying pasture cattle in, and dealers believe this week and next will see the crest of the fall run. Packers are refraining from bidding on feeders, there being plenty of fleshy grass steers available, though they are not averse to seeing a liberal number of heavy cattle go on feed at this time. Country buyers exerted themselves here last month, taking out 118,000 cattle and calves, a good proportion of which went right on feed. That was fifty per cent more cattle than were taken out same month last year, and some of the prophets are forecasting disappointing prices when the short fed steers return. Prime cattle have been a minus quantity here this week, some choice westerns bringing \$9.95 yesterday considered about one dollar under the limit on prime natives. Kansas pasture steers bring \$6.00 to \$8.35, quarantine steers \$4.50 to \$5.75, grass cows and heifers \$3.75 to \$6.00, veal calves a little cheaper this week, tops \$9.50, stock steers \$4.50 to \$6.50, feeders \$5.30 to \$7.00. Hog receipts today 8000, market strong, top \$8.75, bulk \$8.50 to \$8.70. Heavy hogs are gradually taking their accustomed winter position at the head of the procession sales of that class both yesterday and today only a shade under the top. Sheep and lambs met a reverse yesterday, and are barely steady today, at the bottom of the decline of yesterday, run 12,000. Top range lambs today \$6.75, and feeding lambs are going around \$5.75. Figures or the probable number to be fed this season are contradictory, though it is likely that native territory will be short, and the west will feed a normal number.

## ONE SACRIFICE FOR SINS FOREVER

### The Scriptural Testimony Is, "Christ Dieth No More."

A Different View of the Doctrine of the Mass—A Long-Standing Mistake Pointed Out in Respect to It—Referred to by Daniel the Prophet as "the Abomination That Maketh Desolate."

London, Sept. 1.—Pastor Russell's text for today was: "After He (Jesus) had offered one sacrifice for sins forever He sat down on the right hand of God." \* \* \* for by one offering He hath perfected forever them that are sanctified."—Hebrews x, 12-14.

The Bible is most explicit in its declaration that Jesus, as the antitypical High Priest, offers but one sacrifice of Himself for the sins of the world. In our context St. Paul points to the typical sacrifices, "which could never take away sin," and then he tells us that the one sacrifice of the Antitypical Atonement Day, by the antitypical High Priest, is so complete as to leave nothing further to be done—"Christ dieth no more; death hath no more dominion over Him."

### Sacrifice of the Mass.

However, we behold two great Christian communions holding a different view—the High Church of England and the Church of Rome. Both hold the doctrine introduced into the Church about the fourth century—the doctrine of the Mass. This doctrine holds that the death of Christ cancels original sin for believers; but it philosophizes that since sins committed after coming into the family of God need cancellation also, and that since nothing except the blood of Christ, the death of Christ, can take away sin, and the merit of His death at Calvary having been used to cancel our past sins, a fresh sacrifice of Christ is necessary for the more recent sins.

Applying this philosophy, these Christian brethren perform a common, or Low Mass, for general sins in a congregational way, and High Mass for special sins. The congregation assembled, praise and prayer are chanted, and then the officiating priest approaches what they call the altar of sacrifice. On it are the bread and wine, which, being blessed, are "instantly turned into the actual flesh and actual blood of Christ."

### Where Lies the Mistake?

With our convenient Bibles (Catholic and Protestant) we have much advantage over our brethren of the fourth century who invented the doctrine of the Mass. We now see that this doctrine is unscriptural and that the bishops erred—in other words, they were not inspired; they were not successors of the Twelve. Whatsoever things they bound on earth were not bound in heaven.

Bible students see clearly that the one sacrifice of Christ is sufficient for the sins of the whole world—past, present and to come. But God does not propose in any manner to forgive sins willfully committed. They receive stripes, or punishments, in proportion to their willfulness.

Our need then is, not to attend Low Mass or High Mass, but to go directly to the Lord in the name and merit of our Advocate. Thus the Apostle enjoins us saying, "If any man (in the Church) sin, we have an Advocate with the Father, Jesus Christ the Righteous." (1 John ii, 1.) The thought that sin in every instance requires atonement is quite Scriptural and the thought that "without the shedding of blood there is no remission of sins" is Scriptural. (Hebrews ix, 22.) But the thought that Christ needs to die more than once is antagonistic to the Scriptures, as we have seen.

The Abomination of Desolation. Nearly nineteen centuries ago our Redeemer mentioned "The Abomination of Desolation, spoken of by the Prophet Daniel." (Matthew xxiv, 15.) The Master declared that when this Abomination should be seen those noting it should understand and flee. For long centuries the Abomination was supposed to refer to the carrying of Roman banners within the holy precincts of the Temple at Jerusalem. It did seem strange that so comparatively insignificant a matter should be mentioned by Jehovah through Daniel the Prophet and should then be referred to by Jesus Himself; but we saw no other interpretation. Of late there is another interpretation. It refers our Lord's prophecy specially to the end of this Age and the great time of trouble soon to come upon the Church and upon Christendom.

## THE WORLD'S SIN; THE CHURCH'S SIN

### One Redeemer, Christ Jesus, For Both Church and World.

The Bible Nowhere Represents the Devil With Hoofs and Horns and Forked Tail Cavoring Amid Flames Torturing Helpless Beings.

Berlin, August 18.—Pastor Russell delivered two addresses here today. We report the one from the text, "He is the propitiation for our sins (the Church's), and not for ours only, but also for the sins of the whole world." (1 John ii, 2.) He declared that

the Devil of the Bible transforms himself into an angel of light in his endeavors to mislead the people of God and to make void the Word of God. The Bible nowhere represents the Devil with hoofs and horns and forked tail cavoring amidst flames of hell, torturing hapless beings—and stoking fires. The Bible hell is *sheol, hades*—the tomb, the state of death, where both good and bad go and from which all are to be recovered in due time. The Church will be the first: "Blessed and holy are all they that have part in the First Resurrection; they shall be priests unto God and shall reign with Christ a thousand years.—Rev. xx, 6.

During that thousand years all the remainder of the race will have resurrection privileges. The world's resurrection will include not only an awakening from death, but much more. *Anastasis*, the Greek word for resurrection, means a raising up again—implying that the person was once up, fell down and is to be raised up again. The Apostle declares that man fell from perfection and the raising up again is to be human perfection. None will be forced to return, but all the willing will be assisted to obedience—the reward of which will be a gradual uplifting to all that was lost in Eden and redeemed at Calvary. The disobedient, after full opportunity, the Pastor declared, will be destroyed in the Second Death, which the Scriptures symbolically represent as the Lake of Fire.—Revelation xx, 14, 15.

One Redemption—Two Salvations. Pastor Russell called attention to numerous Scriptures which seemed in harmony with his contention that the redemption provided in Jesus is to be co-extensive with the condemnation which came to all through Father Adam. Father Adam alone had been tried and, because of sin, had been sentenced to death. The remainder of humanity have never yet been individually tried. They have merely shared in hereditary weaknesses, mental, moral and physical, and shared also in the hereditary death penalty which involved them in sin, sorrow and pain in conjunction with the ultimate result, death. It is because all were thus condemned through one man's disobedience that the death of the Man Jesus once for all can be justly the redemption-price for the sins of the world.

Christ has died. And the fact that but one class of humanity for whom He died has been blessed should be to us a guarantee that the remainder will be blessed, since "He has tasted death for every man."—Hebrews ii, 9.

Who is so blind as not to be able to see the difference between the Church and the world in our text? It reminds us, said the Pastor, of Jesus' words to His disciples, "Ye are not of the world, even as I am not of the world," "for I have chosen you out of the world."

Not only the Apostles were chosen out of the world and separated by their call and spirit-begetting and development in the School of Christ, but all of the followers of Jesus throughout this Gospel Age have been sharers in this same call to separateness from the world. They walk by faith and not by sight—their faithfulness in living unto the Lord and not for self, is promised the great reward of a share in the Messianic Kingdom glory.

Then when the Church shall have reached her glory will be the time for the world to be blessed. The Church as the spiritual Seed of Abraham (Galatians iii, 29) will with her Redeemer bless all the families of the earth for a thousand years and make good to them their share in the merit of Christ's sacrifice.

Geneva's Monument to Servetus. The Pastor said that a week before he had been in Geneva and looked at the monuments to Calvin and to Servetus (the Christian brother whom Calvin had caused to be roasted alive by a slow fire for five hours). The latter monument had been erected by Calvin's followers to show that they had no sympathy with their leader's course in this matter.

Pastor Russell declared that Calvin had not invented the Doctrine of Election, for it was in the Bible fifteen centuries before he was born. He gave him due credit for having made the doctrine prominent.

With the increasing light now shining upon the Bible, said Pastor Russell, we see that the elect Church when united to her Heavenly Bridegroom will be the Elect Seed of Abraham which God has promised shall bless the non-elect.

HOUSE CONCURRENT RESOLUTION No. 3  
Granting equal rights and privileges to women.

Be it resolved by the Legislature of the State of Kansas, two-thirds of the members elected to each House there concurring therein:

That the following proposition to amend the constitution of the state of Kansas be hereby submitted to the qualified electors of the state for their approval or rejection, to-wit:

SECTION 1. The rights of citizens of the state of Kansas to vote and hold office shall not be denied or abridged on account of sex.

SEC. 2. This proposition shall be submitted to the electors of this state at the election for representatives to the Legislature in the year 1912. The amendment hereby proposed shall be known as the official ballot by the following title: Amendment to the constitution granting equal rights and privileges to women, and the vote for or against such amendment shall be taken as provided by law.

SEC. 3. This amendment, if adopted, shall be known as section 8 of article 5 of the constitution of the state of Kansas.

SEC. 4. This resolution shall take effect and be force from and after its publication in the state book.
