DISCUSS THE CABINET

Indianian Told All About Selections for Various Portfolios and Gives Approval.

Trenton, N. J., Feb. 27.—President-elect Wilson's last active day as Governor of New Jersey was devoted chiefly to a conference with his running mate, Vice President-elect Thomas R. Marshall, of Indiana, who stopped here on his way to Washington.

The President-elect has not given any serious thought as yet to the question of inviting the Vice President to Cabinet meetings, but it is thought likely Mr. Marshall will become a regular attendant at such meetings.

Gov. Marshall and I went over the ground completely, said the President-elect, and we discussed the various aspects of the Presidential campaign.

He has been very generous in his support of me, and I have been very grateful to him.

Mayor of Alexandria Appoints Delegation to Go to Washington in 1915.

Alexandria, Va., Feb. 27.—This city has been invited to participate in the celebration of the 100th anniversary of the Anglo-American peace, which will be celebrated here on the 28th and 29th of February, 1915.

Calling attention to the comparatively small holdings of the directors, the report continues that it is a fact that after a somewhat careful examination of the witnesses on this branch of the case, we were unable to find any one connected with the active management of the company who was not also a member of the board of directors.

The report reviews exhaustively the organization and business of the Protective Holdings Corporation of Syracuse, N. Y., which was organized by Tuttle, Wightman and Dudley.

The criticism of the New York Insurance Department upon the Protective Holdings Corporation and the criticism of the committee upon the Commercial are held to be almost identical.

INTERESTS OPPOSE EACH OTHER

Calling attention to the clause in the underwriting contract which permits the companies to stop in and pass upon risks and cancel policies when the fire loss is excessive, the report says: "The interests of Tuttle, Wightman and Dudley are absolutely tied for the period of fifteen years; they could see their assets being consumed by improvements and writing and be helpless to remedy it."

Concluding the criticism of the underwriting contracts, the report says: "The interests of Tuttle, Wightman and Dudley are diametrically opposed to the interests of the stockholders of the insurance company, and they ought not to be managers of both companies."

"While we deem these contracts unfair to the stockholders, we do not think they are not fraught with the same danger as the underwriting contracts." The profits to Tuttle, Wightman and Dudley, however, are declared to be too great to be voluntarily given up.
