Notice of Teachers Examination.

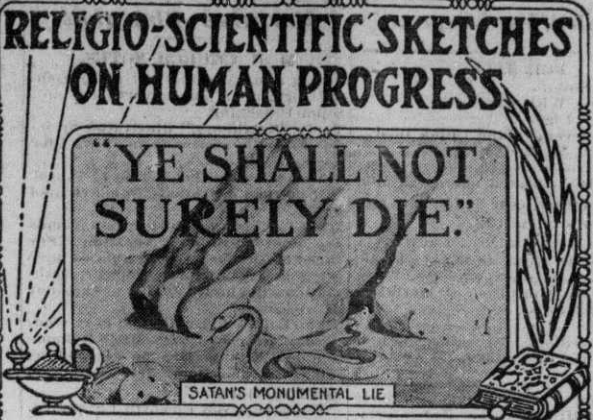

EXPULSION FROM EDEN

The Word of God must stand, whether it be the word promising Eternal Life or the sentence of Death. There is no variability with Him, neither shadow of turning. 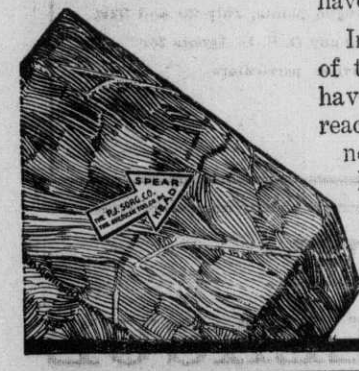
