

## WHY GOD'S WRATH UPON THE NATIONS?

### Outgrowth of Wrong Doing Upon Earth.

Justice of the Day of Vengeance. "Render Unto Her Double"—"The Controversy of Zion"—"The Year of the Redeemed"—Balancing the Books. Preparing For the New Dispensation.

Jan. 3.—Pastor Russell's discourse inquired into the reason why in God's providence the world is ushering into "a Time of Trouble such as was not since there was a nation." (Daniel 12:1.) His text was, "The nations were angry, and Thy wrath is come."—Revelation 11:18.

After introductory remarks upon his text, the speaker read Isaiah 34:1-8; Jeremiah 25:15, 16, 27-38; Isaiah 66:15, 16; Luke 21:24-26; Revelation 6:9-11; 2 Thessalonians 1:3-10. Their united testimony, he claimed, referred to the present time—mistranslated the end of the world; properly interpreted, the end of the Age, inaugurating the New Age—"the world to come." God's people Israel typified Spiritual Israel. All others were called the nations, the people, Gentiles, and were outside covenant relationship with God. We recognize saintly people of all denominations as the true Church, and all others as Gentiles, we shall get into alignment with the Divine mind. From this viewpoint alone can Biblical prophecies be understood.

The Divine rod is to be expected upon the so-called Christian kingdoms—nominal Christians. Responsibility and punishment will be proportionate to failure to live up to knowledge possessed. God's wrath and the coming judgments are wholly different from the creedal legends respecting eternal torture for all except the Elect.

Elsewhere God shows us that the troubles of the Day of Wrath are the outgrowth of human wrong-doing, and that these dire penalties for sin would have wrecked our social and religious fabric long ago, had He not held back the storm of human passion until the end of this Age. Just so soon as that storm shall have taught humanity needed lessons and liquidated long-standing accounts, Messiah's Kingdom, with a clean slate, will be inaugurated.

"The Recompenses of Zion." We have reached the end of the world—end of this Age, the Pastor declared. Then he explained that, although God has provided, through Jesus' sacrifice, for absolute forgiveness of all sins and frailties traceable to original sin, and that certain willful sins have been more or less punished during the lives of the sinners, nevertheless this will not be a full settlement for sin. Persecution of the Body of Christ is a crime against God; and a Divine curse has rested upon their persecutors, whose responsibility has been proportionate to knowledge.

The great trouble closing the Jewish Age was retribution for unsettled claims of Justice (Luke 11:50, 51). The generation then living had far greater responsibility than had those preceding them. They had a great Light, shining from Jesus and the early saints.

The Bible intimates that similar aggregations of punishments are due in the end of this Gospel Age. As Jesus foretold, the Kingdom class have suffered violence, while outwardly the violent have posed as the True Church. The Time of Trouble now beginning will be the squaring of God's accounts.

According to Scripture, the closing of this Gospel Age will witness the martyrdom of the last members of the Body of Christ. In our day a more refined process of persecution obtains. Some are gibbeted by the pulpit; some are roasted in the press; some have their tongues cut out in that their words are misrepresented, and they are denied a hearing. Yet the Bible seems to imply a destruction also.

Babylon—what is known as "the Christian world"—will be punished for these crimes against God's saints. "Christendom" of today corresponds exactly to the Jewry of Jesus' day. Misnaming itself "Christ's Kingdom," it is intent upon the preservation of the great Babylon which it has constructed, willing to do anything to avoid the destruction foretold.

Hypocrisy the Greatest of All Sins. Time was when men really thought that kings ruled as part of Christ's Kingdom, that human destiny was in the hands of the clergy, that the non-elect were doomed to eternal torture. But that day has passed. No longer deceived, the clergy know that Sheol and Hades represent the death state, and not fire or torture in any sense. They see God's character clearly; they perceive that the kingdoms of this world are merely political institutions. Nevertheless, the Divine character is still blasphemed; God is still misrepresented to the people.

Two hundred thousand professed ministers of Christ stand before the world today, telling legends of the Dark Ages and hindering people from a knowledge of the Truth. Does not such hypocrisy, such blasphemy against God, such deception of the people, deserve great punishment, and is it not nigh—even at the door?

## SPARTAN RUSSIAN COLONEL

Kissed His Dead Son and Continued to Give Orders to His Troops.

Petrograd.—The Russian journal Svet tells the following story of the Spartan conduct of Colonel Loupoukhine. He was listening, after the first great battle of Galicia, to the reading of the report of his regiment's casualties.

"We have lost 200 killed and wounded," he was told.  
"How many soldiers killed?" demanded Colonel Loupoukhine.  
"So many."  
"How many officers killed?"  
"Only one."  
"What is the name of this officer?"  
"Lieutenant Loupoukhine."  
"Not a muscle of Colonel Loupoukhine's face moved."  
"Where was the officer killed?" he asked.  
"The place was indicated. He went to the body of his dead son, dismounted from his horse, kissed the forehead and lips of his child, made the sign of the cross, remounted, and continued giving orders."

## CHICAGO GIRL BUYS ARMS

Miss Gladys Lewis Acts as Agent for One of the Nations of Europe.

New York.—That a European government has commissioned an American girl to purchase firearms for use along the battle front in Europe developed when it was learned that Miss Gladys A. Lewis of Chicago is the mysterious "G. A. Lewis" who has been negotiating with the Standard Arms Manufacturing company of Wilmington, Del., for all the military rapid-fire guns that concern can make in the next two years, regardless of cost.

The name of the government has been withheld for obvious reasons, but it was confirmed that Miss Lewis is the official representative in the negotiations.

## IGNORES KAISER; SAVES ARMY

Ruler Reported to Have Advised Suicide for General Who Disobeyed His Orders.

Paris.—The entire German left wing would have been annihilated during the battle of the Marne if General von Hausen had not disregarded the kaiser's orders, declares the Warsaw Gazette in confidential reports from Berlin. When the battle was going against the Germans the kaiser commanded the left to continue the advance, but Von Hausen, realizing his flank was strongly menaced, refused to obey.

When the news reached the kaiser of the Prussian guards' retreat from Vitry-le-Francois he said bitterly: "Is General von Hausen still alive? A Samurai would have committed suicide."

## SHEEP LEAD BATTLE CHARGE

Then Cossacks Ride Over Animals' Bodies to Overcome Wire Entanglements.

London.—A correspondent of the Daily Mail, who has been traveling in the East Prussian field of operations, describes a Cossack device to overcome wire entanglements. He says: "This being a great grazing country, when troops of Cossacks are charging batteries they drive immense flocks of sheep and cattle before them right on to the tangled mass of wire. They then charge their horses over the platform of flesh, sabering the gunners in the very trenches behind."

"This plan, however, was soon imitated by the Germans, who were just as fearless and successful in carrying it out."

## LUNATICS LOOSED IN FRANCE

Unfortunates From Asylum in Northern Part of Country Are Near Starvation.

Paris.—The war correspondent of the Journal, Andre Tudesque, in describing the past week's hostilities in northern France, says after taking Baillieu, the Germans turned loose hundreds of lunatics from a big insane asylum located there. The unfortunates wandered through the devastated country for days suffering from cold and hunger. Some died from their privations. The French soldiers found a number of the lunatics hiding in ditches and many are still at large.

## Make Rampart of Dead Men.

Paris.—In one of the hottest corners of the vast battlefield of the Marne the Germans were hard pressed by the French, and driven from their trenches. To check the victorious advance of the French troops they raised a rampart of dead and wounded. This wall, six feet high, the Turks had to scale before they dislodged the enemy with their bayonets. In this corner of the fighting 7,000 German dead were found.

## Start Risk Bureau.

Washington.—War risk marine insurance bureaus, similar to that recently put in operation by the United States, have been established by the governments of Belgium, Denmark, France, Germany, Greece, Great Britain, Italy, Japan, Norway and Sweden, according to announcement made today by the department of commerce.
